ORDINANCE 2015-261**

**AN ORDINANCE AMENDING ORDINANCE 2014-258 (2014 FEE SCHEDULE),**

The City Council of the City of Lonsdale hereby ordains:

Ordinance 2014-258 of the City Code of the City of Lonsdale is hereby deleted and in lieu of, the following shall be inserted.

**WHEREAS**, certain provisions of City ordinances provide for the establishment of fees and charges by the City; and

**WHEREAS**, staff has submitted recommendations for fees to be charged under certain ordinances set forth below for the calendar year 2015.

**NOW, THEREFORE, THE CITY OF LONSDALE DOES HEREBY ORDAIN:**

**SECTION 1.** This Ordinance shall establish the fees identified herein for the calendar year 2015 and the level of such fees shall continue thereafter until changed by City Council ordinance. Any fee currently charged by the City which is not changed by this ordinance shall continue at the level charged prior to the adoption of this ordinance until changed by Council action. Omission from this ordinance shall not be deemed to be a waiver by the City of its right to charge a particular fee.

**SECTION 2.** The City of Lonsdale shall charge fees pursuant to the respective ordinances listed below as hereinafter set forth:

Upon the City and Builder entering into a Deferred Payment Agreement, the Water and Sewer Access Connection (WAC/SAC) fees for residential dwellings shall be deferred until the earliest of the following events: (1) a change in ownership of the Subject Property including a change in Builder's corporate identity or (2) twelve (12) months from the City issuing a building permit for the Subject Property.

## Water And Sewer Usage Charges As of 1/08/15

### 1. Residential and Business Water Charges:

### 2. Sewer Charges:

Base Fee = \$20.00 per month  
\$6.20 per 1,000 gallons

The sewer rate is based on the average of the January, February and March water usage. The sewer rate for new utility customers who begin service other than the first full three months of the year shall have a base rate of 15,000 gallons if usage is greater than 10,000 gallons. If the usage is less than 15,000 gallons, the customer will be charged for the exact usage. This rate will be charged to the customer each billing cycle until the first full month of the following year. For the months of January, February and March, customers will be billed on the actual water usage. Between the months of April and December, customers will be billed on the average water usage for January, February and March.

All customers of the municipal water system shall be billed the base fee for water and sewer unless the City has disconnected their water supply by shutting off the water at the curb stop.

### 3. Sewer Rate Adjustments:

The City Council will consider an adjustment to a customer's average sewer rate billed when circumstances warrant it. Circumstances that will be considered by the City Council include: a defective water meter, plumbing fixtures that leaked and have been fixed or plumbing fixtures that were not programmed correctly and have been reprogrammed. Any adjustment made, will only be made for up to three months after the need for an adjustment started.

### 4. Finance Charge:

- No Approved Payment Plan: 10% of unpaid balance on bills past due
- Approved Payment Plan: 10% of unpaid balance on most recent month past due and 5% on remaining unpaid balance. Payment Plans shall only be allowed for accounts 90 days or less past due.
- Convenience Fee: \$2.99 for each payment made by debit/credit card or e-check.


